Ride 3 days. Trail ride mostly wooded, cross creeks, ride down a creek, & along a creek with several beautiful water falls. Porta-Potties & horse water. SATURDAY YOU ARE ABLE TO STOP AT WINERY FOR A WINE TASTING FEE PD AT THE WINERY. NO OUTSIDE ALCOHOL ALLOWED AT THE WINERY. Hitching post are available at the winery. Any wine purchases made will be delivered bk to camp. Campers welcome on Friday. Horse water is available, but plan to bring your own as well. This is primitive camping, no hook-ups, no electric. DINNER WILL BE AVAILABLE FRIDAY NIGHT FOR A DONATION, BREAKFAST SAT MORNING FOR A DONATION, DINNER SAT NIGHT INCLUDED IN RIDE FEE, AND DJ FRIDAY & SATURDAY NIGHT. DINNER SERVED SATURDAY EVENING STARTING @ 5PM. LUNCH ON THE TRAIL FOR DONATION BY THE TWINS LAKES SEARCH AND RESCUE.

FRI: 7 mile ride (DOES NOT INCLUDE THE WINERY) ride anytime on Friday.

SAT: LONG RIDE 17 MILES OR SHORT RIDE 14 MILES. RIDE OUT BY 10:30 AM.

SUN: THE FRIDAY RIDE IS THE ONLY RIDE AVAILABLE TO RIDE

DOGS ARE ALLOWED ON THE TRAILS, IF YOU PACK IT IN PLEASE PACK IT OUT, and remember that you are riding on several different land owners property, & without them this ride would not be possible. Under 18 helmets are recommended.

RULES AND WAIVER MUST BE SIGNED

Rules of the Ride: I understand additional ride information may be posted at the rides. I agree to respect all property and to follow trail marker. I shall protect crops and property by staying on the marked trails and I am responsible for keeping my mount under control. I shall observe trail etiquette and will adhere to any instructions from outriders.

I UNDERSTAND THAT HELMETS ARE RECOMMENDED FOR RIDERS UNDER 18. PARENTS MUST ACCOMPANY & RIDE WITH CHILDREN UNDER 18 OR PARENTS MUST RELEASE LIABILITY FOR CHILDREN 16-18 NOT ACCOMPANIED BY PARENT.

WAIVER. In consideration of being permitted to participate in this equine activity, the undersigned (Releasor) executes this Waiver and Release of Liability and Indemnity (Release) and hereby agrees as follows. Releasor is aware of the risks of injury and death inherent in Equine Activity and acknowledges that (s )he has read the above Rules which are incorporated into and made part of this Release by this reference. Releasor hereby expressly assumes all risk associated with all such Equine Activity. Releasor hereby releases, waives and discharges Trails of Hope, its officers, members, directors, all other persons or entities acting on behalf and any and all landowners allowing the use of their land for this equine activity, and all participant organizers (collectively, the Releasees) from all liability to Releasor, and his or her spouse, legal representatives, hired, successors and/or assigns, for any loss, injury or damage, and any and all claims therefore, on account of injury to Releasor's person or property, or the death of Releasor while Releasor is engaged in any equine activity. Releasor hereby waives his or her right to sue Releasees on account or injury to Releasor's person or property, or the death of Releasor while Releasor is engaged in equine activity. Releasor hereby indemnifies and agrees to hold harmless Releasees and each of them from any loss, liability, damage or cost that may incur due to Releasor's presence in, upon or around property being used by the organizer's for the purpose of this equine activity, or due to Releasor's participation in such equine activity regardless of where such participation may occur. This release is governed by and shall be constructed in accordance with Virginia Code. **3.2-6202. Liability limited; liability actions prohibited under the Virginia Code** A. Except as provided in 3.2-6203, an equine activity sponsor, an equine professional, or any other person, which shall include a corporation, partnership, or a limit liability company, shall not be liable for any injury to or death of a participant resulting from the intrinsic dangers of equine activities and, except as provided in 3.2-6203, no participant nor any participant's parent, guardian or representative shall have or make any claim against or recover from any equine activity sponsor, equine professional, or any other person for injury, loss, damage, or death of the participant resulting from any of the intrinsic dangers of equine activities.

B. Except as provided in 3.2-6203, no participant or parent or guardian of a participant who has knowingly executed a waiver of his rights to sue or agrees to assume all risks specifically enumerated under this subsection may maintain an action against or recover from an equine activity sponsor or an equine professional for an injury to or the death of a participant engaged in an equine activity. The waiver shall give notice to the participant of the intrinsic dangers of equine activities. The waiver shall remain valid unless expressly revoked in writing by the participant or parent or guardian of a minor.
